## BANK ACCOUNT DEBIT MANDATE

Dear Member,

In order for RCI to confirm your instruction, we ask you to please complete the below bank account debit mandate which would cover any future timeshare exchanges, rental bookings, membership renewals or any other auxiliary product with RCI. This mandate replaces any previous debit mandates submitted, whether this was done in writing or telephonically through our Call Centre.

RCI will debit you for any exchange, rental transaction, membership renewal or auxiliary product using the mandated bank account, if you opt for this pay method, on your agreed debit date for the amount agreed upon when confirming your transaction. Your annual membership fee will be debited in the calendar year for the following year's membership. Should a debit from your nominated account be unsuccessful, RCI will debit the account again by the last business day of the month following the original debit.

As we are unable to advise future debit dates and amounts, as these do change annually, we will advise you in advance, as per CPA regulations, of the amount of the annual membership fee payable and the date upon which your annual membership fee will be deducted from your account in that calendar year for the following year's membership.
